We support the health and well-being of seriously ill or injured children receiving treatment in the Dallas area by providing them and their families a home-away-from-home. In an effort to reduce stress, keep the family intact, and enhance the lives of the families in residence, the House allows families to re-establish some sort of a normal routine and also provides them with the opportunity to share their concerns with others, who are in a similar situation and can truly understand what they are experiencing.

Form 990, Part III, Line 4a - Program Service Accomplishments

Ronald McDonald House of Dallas (RMHD) was established in 1981 as Dallas' only temporary home-away-from-home for families with seriously ill or injured children receiving essential medical care and has served 40,000 families over the years.

With approximately 78,000 square feet, the House offers 77 private bedrooms, six long-term stay suites and 6 transplant apartments available for bone marrow, stem cell or organ transplant patients who require isolation from the rest of the families in the House. Additionally, the House has many common areas for kids of all ages and interests, including a library, media room, craft room, play room, game room, teen room, chapel, meditation garden, splash pad, and large outdoor play areas. Two large communal kitchens and a dining room provide opportunities for the families to share meals together, which are provided 3 times a day by community volunteers, or to prepare their own food if they choose. There is also a Day Program which offers families of hospitalized children a place to rest and regroup away from the stress of the hospital but do not need an overnight stay.

COVID-19 had a tremendous impact on RMHD and the way families were served. Mid-March brought the difficult decision to suspend volunteers and groups. Intakes of new families was suspended for 10 weeks in order to learn more about COVID and to implement protocols to insure everyone’s safety. Throughout this period, the House continued to serve the families already in its care. All the common spaces in the House were closed and all meals were served in single serving containers. Families ate these in their guest rooms or outside in the courtyard rather than in the dining room. Following the pause in intakes began a four-phased plan to bring in new families slowly and strategically. Procedures and protocols were effective and there was no spread of COVID cases at RMHD.

Despite the challenges of COVID, children were served at RMHD and the family room with a total of 7738 onsite room nights. An additional 31 families were provided hotel stays for a total of 277 nights. The average length of stay increased to 17 nights. The Family Room at Scottish Rite for Children in Frisco did have to close for the remainder of the year. Even in the absence of cooking groups, and with most meals being catered, families were still served three meals a day.

While RMHD was unable to provide the usual activities, the House was able to host a few outdoor, socially distanced activities as well as provide activities virtually or individually so families could participate in their own rooms.

In 2020, over 463 children were served with a total of 7,738 nights. The average length of stay was 17 nights. Three meals a day continued to be serve the entire year, including during the pandemic.
