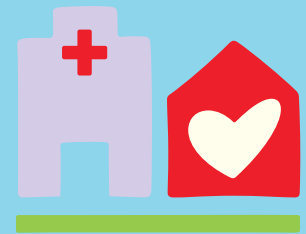

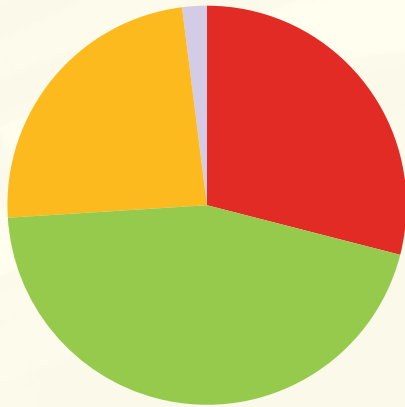

Fiscal Year 2025 Operating REVENUE

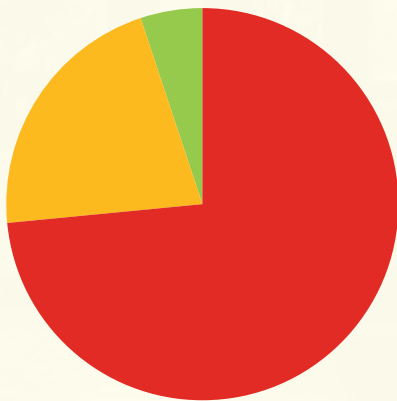


- Special Events = 29%

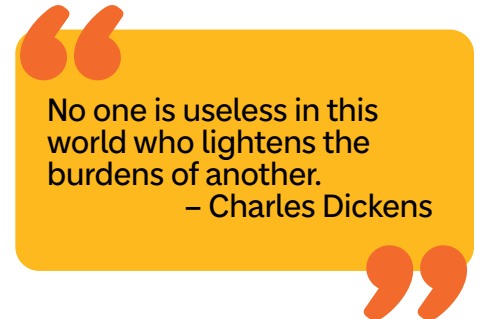
